

Q COMMUNITY \$5000 DONATION FACEBOOK COMPETITION

*Q Community Donation ("Promotion") Terms and Conditions of Use ("Terms").

1. Participation in the Promotion constitutes acceptance of these Terms.
2. The Promotion commences on Monday 14th May 2018 12 mid-day AEST and closes on Sunday 27th May 2018 at 12 Mid-day AEST ("Promotional Period").
3. The Promotion will be conducted over 14 days and the Promoter ("Promoter") is Jen Management QLD Pty Ltd ABN 61 080 874 – Q Super Centre, Corner Bermuda and Markeri Streets Mermaid Waters Qld 4218.
5. Entry is restricted to Community Groups, Sporting Clubs and accredited Not for Profit Organisations operating within the City of Gold Coast.
6. Community Groups, Sporting Clubs and accredited Not for Profit Organisations are only permitted a single nomination.
7. Nominees will be profiled for voting commencing 11th June 2018.
8.
