

Kia Picanto Competition

Q Kia Picanto 3 Car Giveaway (“Promotion”) Terms and Conditions of Use (“Terms”).

1. Participation in the Promotion constitutes acceptance of these Terms.
2. The Promotion commences on Wednesday 1st September 2021 at 10am AEST and closes on Tuesday 30th November 2021 at 12 Mid-day AEST (“Promotional Period”).
3. The Promotion will be conducted over 90 days. 4. The Promoter (“Promoter”) is Jen Management QLD Pty Ltd ABN 61 080 874 – Q Super Centre, Corner Bermuda and Markeri Streets Mermaid Waters Qld 4218.
5. If a customer makes a purchase during the promotional period at Woolworths, Coles, Aldi of \$100 or more, then the customer is eligible to receive one (1) entry form for the Promotion per transaction/receipt. If a customer makes a purchase during the promotional period at a participating specialty retail store of \$20 or more, then the customer is eligible to receive one (1) entry form for the Promotion per transaction/receipt. The Promoter may at its absolute discretion, suspend, cancel or recommence the Promotion if (a) for any reason the Promotion is not capable of proceeding as planned; (b) if the Promotion is corrupted or the administration, security, fairness, integrity or proper conduct of the Promotion is affected; or (c) if the determination of the Winner or delivery of prizes is prevented or hindered by any event outside the Promoter’s control subject to regulatory authorities.

Except for any liability not excluded by law, entrants release and indemnify the Promoter from and against all actions, claims and liabilities, that the entrant now has or in the future may have against the Promoter for any loss, damage, or injury (including any special or consequential loss) suffered as a direct or indirect result of the entrant’s participation in the Promotion.

20. By entering the Promotion, entrants’ consent to their personal information being used by the Promoter for (a.)
